About the Grants

The Lutheran Church Extension Fund is a nonprofit ministry of the church, therefore fiscal year end operating results are put right back into mission and ministry. LCEF is blessed by strong investors and faithful borrowers. It's a partnership that's working, thus we have grant funds available to our Minnesota South District - Lutheran Church Missouri Synod organizations.

There are five LCEF Outreach Event Grants available to all Minnesota South District LCMS organizations; each grant is worth \$1,000.

Qualifications

All member Minnesota South District - LCMS organizations are eligible. To be considered for a grant, the organization must:

- ❧ Conduct a **specific outreach/evangelism event** designed to reach those who don't know Christ *within one year* of receipt of this grant.
- ❧ Reflect the goals of LCEF's mission statement (see page two of our monthly newsletter or visit lcef.org).
- ❧ A representative of your organization **must be present to accept the grant at the spring LCEF conference on March 13th, 2010** at Good Shepherd Lutheran Church in Owatonna, MN.
- ❧ Provide photos and a written summary of the outreach event funded by this grant to this office (*within one calendar year of receipt of grant*) for promotional purposes. Previous winners who have not submitted feedback will not be considered for this year's award.

Entry Information

This completed application (*see reverse*) must be accompanied by a typed description of the congregation's specific outreach event. This narrative should describe the Outreach Event, as well as provide reasons why your organization should be selected as an LCEF Outreach Grant recipient.
